The Tiwi Land Council members are very pleased that the TO Register is being maintained.


Emma presented each Trustee, a clan group list of all the current members and a new member template at a full land council meeting held on Melville Island in December.

CEO's Message

There will be meetings held with individual clan groups during the year for the purpose of verifying the existing list of members, since members could move to different locations. Births and Deaths may need to be updated too.

The traditional owners register is an ongoing function of the Registrar.

We have met with several clan groups to do discuss issues affecting their land, they include:

- Tikilaru in relation to Sand Extraction, also to advise the completion of leases for the Lighthouse at Cape Fourcroy and the Bathurst Island Lodge transfer to Matt Wright.
- Yimpinari to discuss potential mining on their land and Administration matters in relation to TIA.
- Mantiyupwi outstanding lease payments, relating to several leases have been addressed. Work will commence soon on the new Centre/Pontoon/Jetty.
- Munupi TLC is still working with OTL, Munupi and Tuwanapila Directors to expedite the release of funds connected with the Economic Development Plan and Charitable Status requirement.

Our Chairman Gibson and I attended a joint meeting with all CEO'S & Chairmen from Land Councils recently to discuss the National Partnership Agreement with Minister Scullion in Alice Springs.

Minister Scullion has indicated that all the Land Councils should have input into the delivery of housing across the NT for indigenous people. The Land Councils agree to having a direct involvement with the Commonwealth Government and the NT Government in how remote Indigenous housing should be delivered.

TLC has also received support from ABA - (Aboriginal Benefit Account) to fund some works on outstations. We have been working closely with TIRC to determine where this funding can be allocated. Unfortunately, funding is restrictive in how it can be applied. It cannot be used for repairs to housing. Assessments have been conducted on all outstations and bush holiday camps late last year by me and other government entities. Samir Raut (NBC Consultants) has also been involved in the process. TLC full council endorsed that the funding should apply to the outstations only on this occasion. As we move forward, we will continue to consult and meet with clans, organisations including the NTG and Commonwealth Govt's to work towards a better and prosperous Tiwi future.

We are working with the Tiwi Land Council to move the Tiwi Ranger program fully into Tiwi Resources, partly funded through a 3-year contract with ILC for fire management.

Other projects coming under the Tiwi Resources umbrella include a land use planning project with Deakin University in Melbourne, and a bush medicine project with Menzies. Both projects involve consultation with community, and we look forward to talking with families about them. Getting input and advice from the community is a key aspect of how we want these projects to proceed.

Tiwi Forestry update

2019 is leading up to be a busy year for PMP and TPC.

After the loading of two vessels (log and woodchip) in December the forestry project has seen a big maintenance shutdown, this has seen a lot of the equipment being repaired but also new trucks and equipment being purchased to help make the project more efficient this year.

Operations will ramp up in

April and remain very busy until

December. What does this mean? The roads will have larger trucks operating on them but more road maintenance. It also means less trucks on the roads due to the trucks carting larger loads.

The opportunities for work have increased, Operating machinery, trucks and also road works, port works and loading vessels.

Tiwi Rangers NAPCAN training

In late February Tiwi Land & Marine Rangers completed two and a half days of training with the National Association for Prevention of Child Abuse and Neglect (NAPCAN).

NAPCAN's strategy is to support and encourage changes in individual and community behaviour to stop child abuse and neglect before it starts.

Rangers regularly do school talks and take students on work experience, so this training is important.

During the training Rangers learned that proatecting children is the responsibility of every adult.

Rangers will work to keep children connected to family, community, language and culture and be leaders who stand up for the rights of children and advocate for their best interests.

Rangers will encourage an environment for children where they feel safe, thrive and can develop positive relationships with adults and peers.

All Rangers are required to have an Ochre Card as part of their Commonwealth Funding Agreement.

Anybody who comes into contact with children through their work is required by law to have an Ochre card.

Planning for sustainable land use on the Tiwi Islands



Late last year we heard the news that a new research project will be funded by the Australia Research Council, in a partnership between the Tiwi Land Council, Deakin University (in Melbourne), Melbourne University, and Charles Darwin University. The project aims to bring together Tiwi knowledge and scientific knowledge and information, to support Tiwi decisions about land management and development on the Tiwi Islands.





The research team includes many familiar faces, including Alan Andersen (previously with CSIRO), Hugh Davies and Marg Ayre, and some people working with Tiwi for the first time: Emily Nicholson, Jane Elith, Guru Guillera-Arroita, Brett Bryan and Tom Kompas. Many of us visited the Tiwi Islands in 2016 (see photo) and in December 2018, and have attended SRC meetings. Importantly, we have funding to employ a Tiwi research assistant to work with us on the project.

The first steps of the project will be to work with Landowners to identify what is important for Tiwi people that land management and development can affect, both positively and negatively. We will do this through meetings and discussions, like our discussions with Landowners and Rangers in 2016. This includes working out what different options are for management and development, and how they might affect things that matter to Tiwi people, such as mangroves, special places and plants and animals. For example, one option is a new Indigenous Protected Area, and we want to measure how it can benefit people and nature. Hopefully we will be able to provide information that Tiwi decision-makers need to make the best decisions for Tiwi land and Tiwi people.

An exciting part of this meeting was formalising the committee through a Memorandum of Understanding and Terms of Reference.

Some of the topics covered were:

How to measure and manage the impacts of fishing on Tiwi waters. Creating a system for storing information about Tiwi plants and animals that Tiwi people can look at on their phones.

Research about how fire affects the way young trees grow on country.

Finding out how many feral cats there are on the Islands, and how much damage they are doing to Tiwi animals.

A project with Tiwi Marine Rangers to see how turtle eggs would survive rises in sea level. How Tiwi communities might be affected by climate change, and what we can do about it.

Collecting Tiwi cultural information and bringing it home.

Finding out how Tiwi animals are affected by fire.

The best way of creating conservation areas on the Tiwi Islands.

A project talking to Landowners about long-term land use planning, and how they want their country to look in the future.

What's happening at Port Melville?

December and January were a very busy period at the Port. On 27th December the bulk carrier 'MV Alpha Bulker' departed loaded with 13,000 cubic metres of pine logs and on 2 January the 'MV Green Harvest' departed with approximately 35,000 tonnes of woodchips.

This represents shipment #1 of Tiwi pine logs and shipment #15 of woodchips to the world.

Both these loading operations were achieved safely, which is a credit to the Port and PMP teams.

Bunkering operations also continue to progress with several vessels taking fuel at the Port.

There have been several meetings in relation to the new Morgue on Bathurst Island. We have been advised by NT HEALTH, that they will manage the morgue and it is now in a satisfactory position for operation.

ceased persons. This may also assist with reducing the cost associated with funerals.

TIRC has committed to having a space to hold flat pack coffins and the running of the ferry service out of hours if there becomes a need to travel to Melville Island to transfer a deceased person to the Morgue.

TLC has purchased a morgue/funeral 4x4 vehicle to assist with funeral and transportation of de-

Land Council is not funded by the government and does not have the money to fly family anywhere in relation to funerals.

They are also not funded to provide for dancers or food.

Costs increase when a deceased person must be flown to Darwin. The Morgue can only hold a deceased person for a limited amount of days before the body would have to be flown to Darwin as the Morgue facility is not a Freezer. Where possible funerals should be conducted on island within 7 days of the death of a person.

It is important to note that Tiwi Land Council is funded a set amount to assist in the holding of a funeral. Tiwi Enterprises arrange the funerals and Ray has done a great job over the years for us. Once the amount of money Land council is allocated is spent, then fami-Clans may be able to assist.
